- Assists in interfacing with state and federal regulatory agencies and preparing reports as required.
- Arranges all necessary external training/audits.
- Conducts work safely and adheres to the company's health, safety, and security policies and procedures.
- Ensures integrity of health, safety and security data and information.
- Performs other tasks within the scope of the role as assigned.
